In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the Annual Crop Report for 2000. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. I wish to emphasize that this report represents gross returns to the producer and does not indicate actual net profit.

The total agricultural production value in 2000 was \$919,610,000. This is a 10.5 percent decrease from the revised 1999 value. Revisions were made to the 1999 seed and nursery crops section. The only increase in value was in apiary products (5.5%) which was a result of an increase in the number of hives used for honey and pollination. Fruit and nut crops and field crops remained fairly stable. Decreases in value occurred throughout the remaining categories: vegetable and melon crops (-20.7%), livestock (-1.9%), and seed and nursery crops (-9.5%). Livestock saw a decrease in the number of head slaughtered while the crop decreases were due in part to lower prices and yields. An acreage shift also occurred from the higher value vegetable crops (-15%) to the more stable field crops (5.7%).

As a measure of how agricultural production impacts the County, for every thousand dollars of total gross value produced, \$345 dollars of personal income are generated to agriculturally related jobs.

I wish to thank all the individuals and organizations for their cooperation in providing the information required for the compilation of this report. I wish to especially thank the staff that produced this report for their dedicated work.

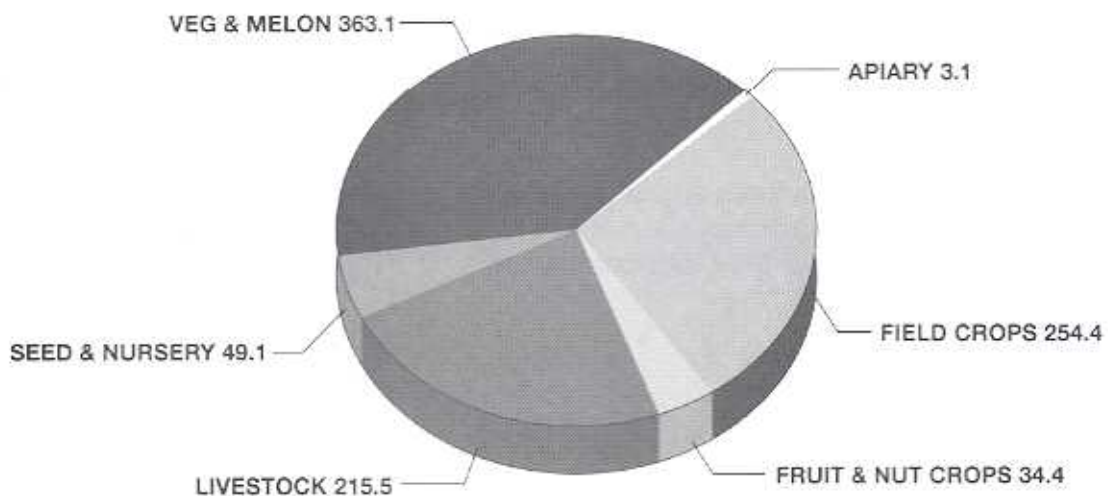

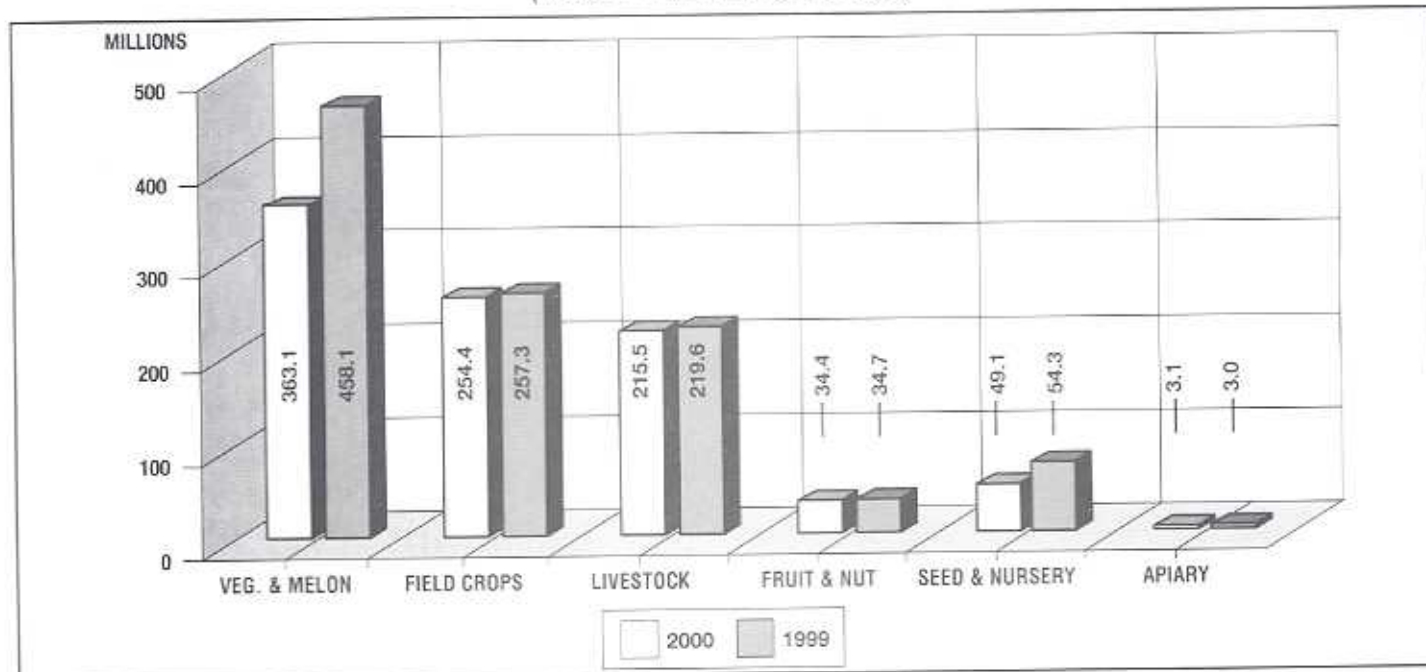

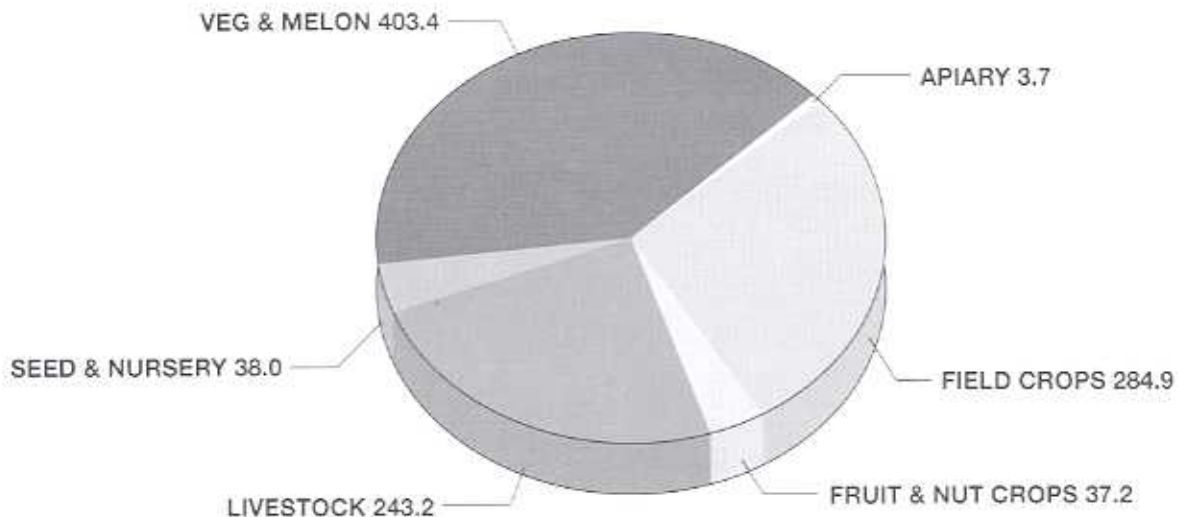

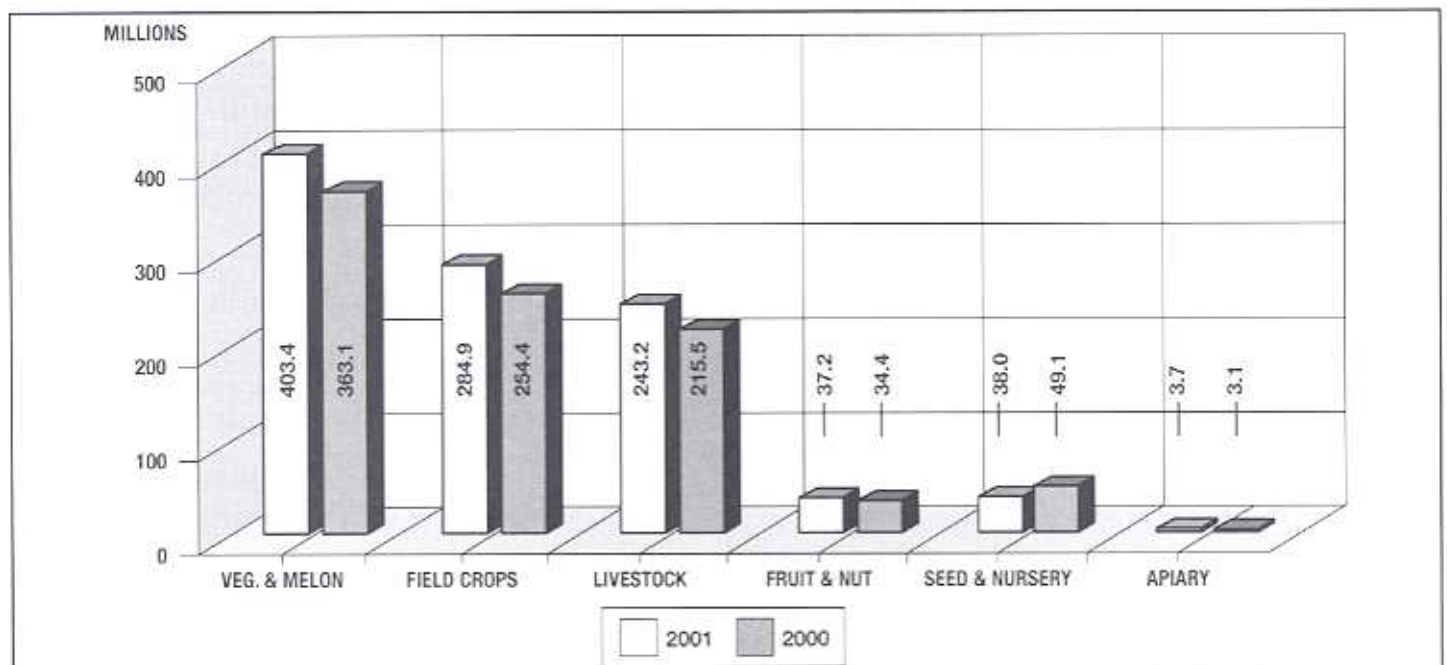

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2002 Annual Agricultural Crop and Livestock Report for Imperial County. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and do not take into account the various costs of production, marketing, or transportation. **No attempt is made to reflect net income of the producer.**

The total gross agricultural production value in 2002 was \$1,224,109,000. This is a 21.2 percent increase or \$213,788,000 from the 2001 gross value. The Vegetable and Melon Crop Category increased 37.9%. The majority of the winter vegetables, lettuce in particular, benefitted from extremely favorable overall prices and accounted for \$154,164,000 of that increase. Increases in value were also realized in, Livestock 16.2%, Fruit and Nut crops 47.1%, Seed & Nursery Crops 40.8% and Apiary products 18.8%. The increases in value were a direct result of improved yields and prices. There was a minor decrease in value in Field Crops (4.2%).

As a measure of how agricultural production impacts the County, for every thousand dollars of total gross value produced, \$399 dollars of personal income are generated to agriculturally related jobs.

I wish to thank all the individuals and organizations for their cooperation in providing the information required for the compilation of this report. I wish to especially thank the staff that produced this report for their dedicated work.

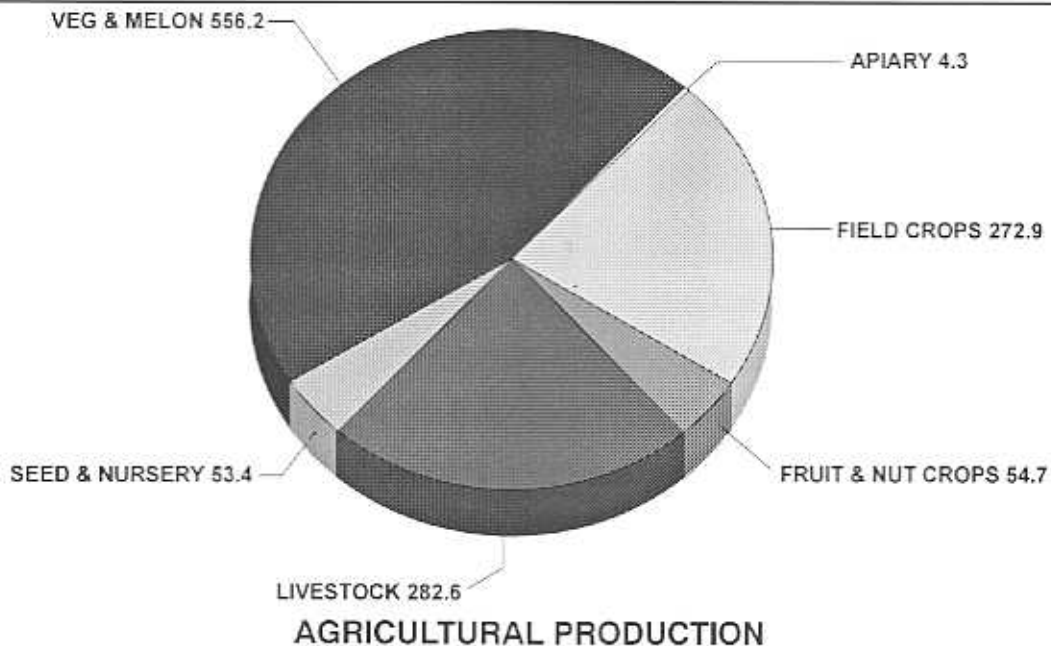

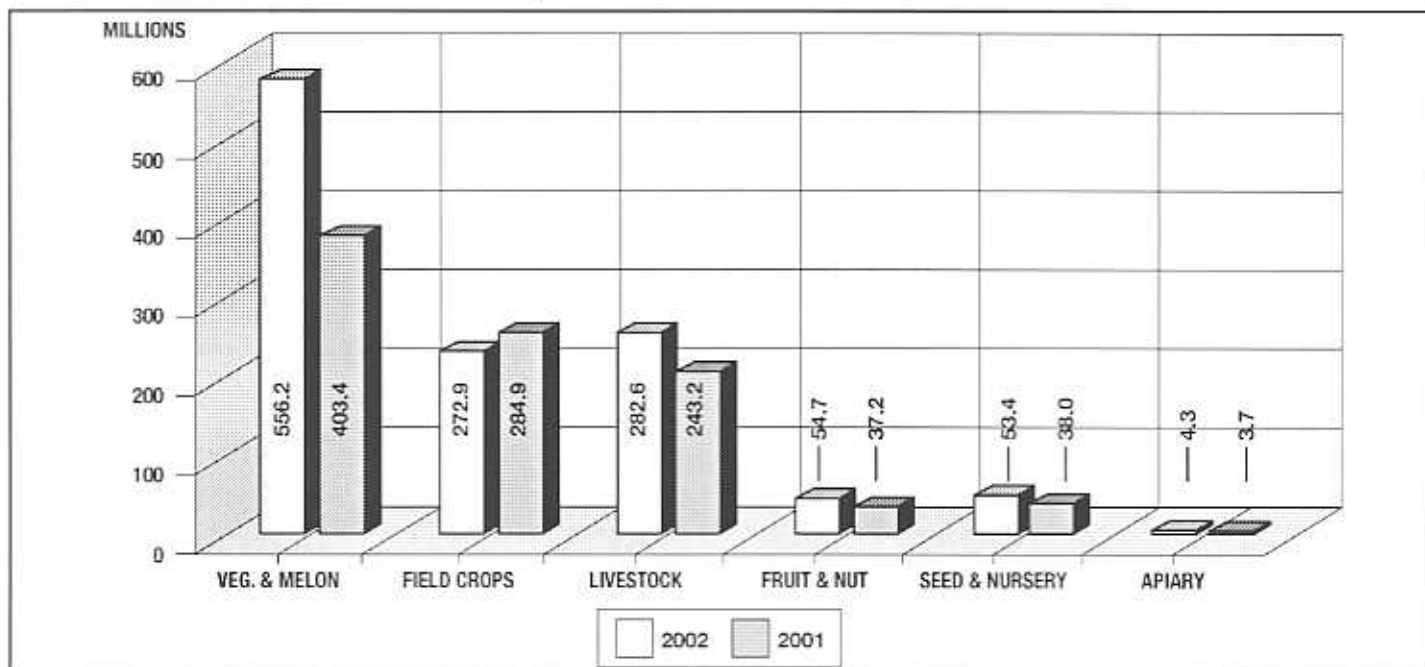

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2003 Annual Agricultural Crop and Livestock Report for Imperial County. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and **do not** take into account the various costs of production, marketing, or transportation. **No attempt is made to reflect net income of the producer.**

The total gross agricultural production value in 2003 was \$1,073,473,000. This is a 10.45 percentage decrease from the 2002 gross value. Increases in value were realized in Livestock 7.24%, and Apiary products 25.44%. Increases in value were a direct result of improved yields and prices. There were decreases in value in Field Crops (10.4%), Vegetable and Melon Crops (16.55%), Fruit and Nut crops (35.25%) and Seed & Nursery Crops (21.12%). Decreases in price and yield were the main factors for the reduction.

As a measure of how agricultural production impacts the County, for every thousand dollars of total gross value produced, \$392 dollars of personal income are generated to agriculturally related jobs.

I wish to thank all the individuals and organizations for their cooperation in providing the information required for the compilation of this report. I wish to especially thank the staff that produced this report for their dedicated work.

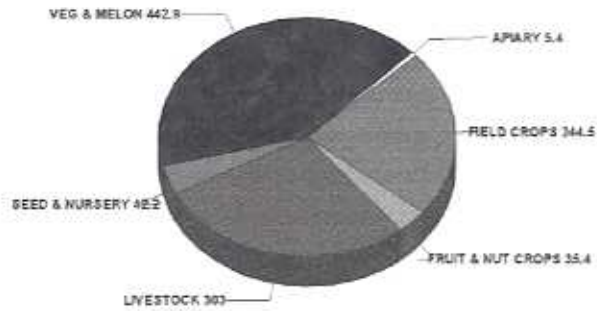

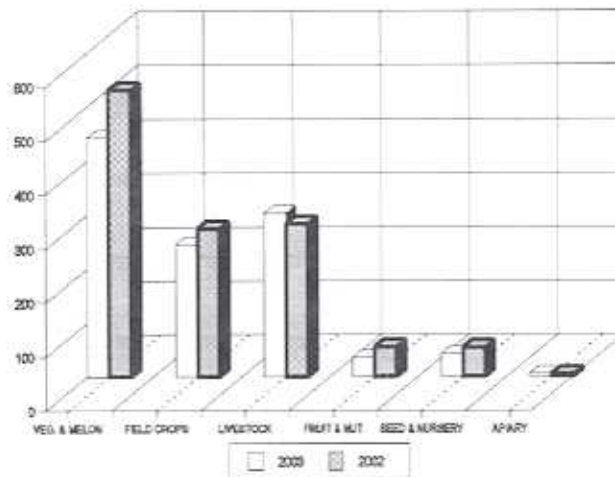

In accordance with the provisions of Section 2279 of the California Food and Agricultural Code, I am pleased to submit the 2004 Annual Agricultural Crop and Livestock Report for Imperial County. This report is a summary of acreage, yield, and gross value of agricultural production in Imperial County. It must be emphasized that the values presented in this report represent **Gross** receipt of producers and **do not** take into account the various costs of production, marketing, or transportation. **No attempt is made to reflect net income of the producer.**

The total gross agricultural production value in 2004 was \$1,187,254,000. This is a 10.6 percentage increase from the 2003 gross value. Increases in value were realized in Vegetable and Melon Crops 14.07%, Field Crops 4.4%, Livestock 6.86%, Fruit and Nut crops 57.29% and Seed & Nursery Crops 4.05%. Increases in value were a result of increased acreage in vegetable crops and increased livestock numbers plus improved prices. The only decrease was in Apiary products (38.32%). Decreases in yield and price were the main factors for the reduction.

As a measure of how agricultural production impacts the County, for every thousand dollars of total gross value produced, \$397 dollars of personal income are generated to agriculturally related jobs.

I wish to thank all the individuals and organizations for their cooperation in providing the information required for the compilation of this report. I wish to especially thank the staff that produced this report for their dedicated work.

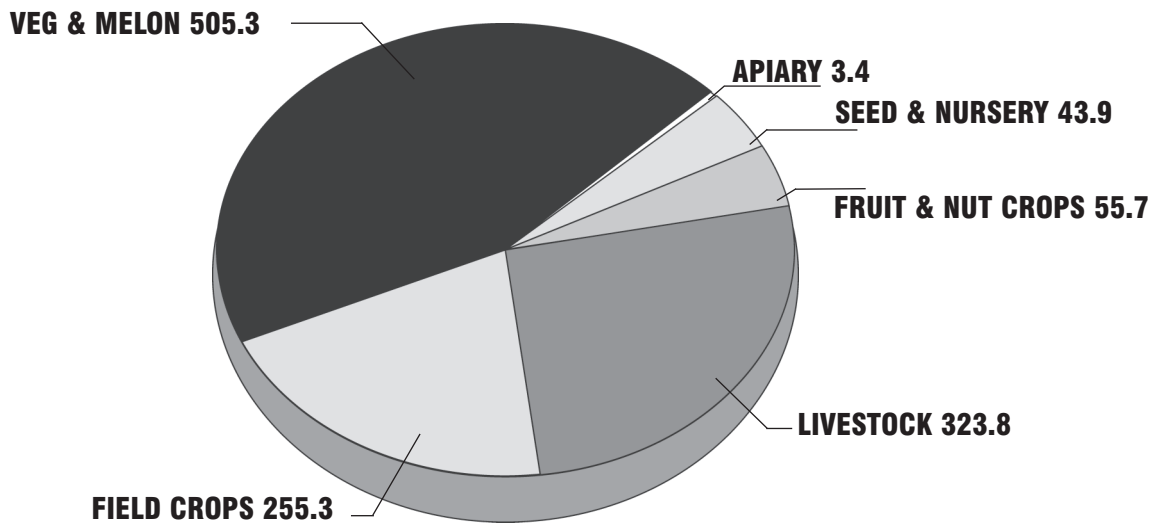

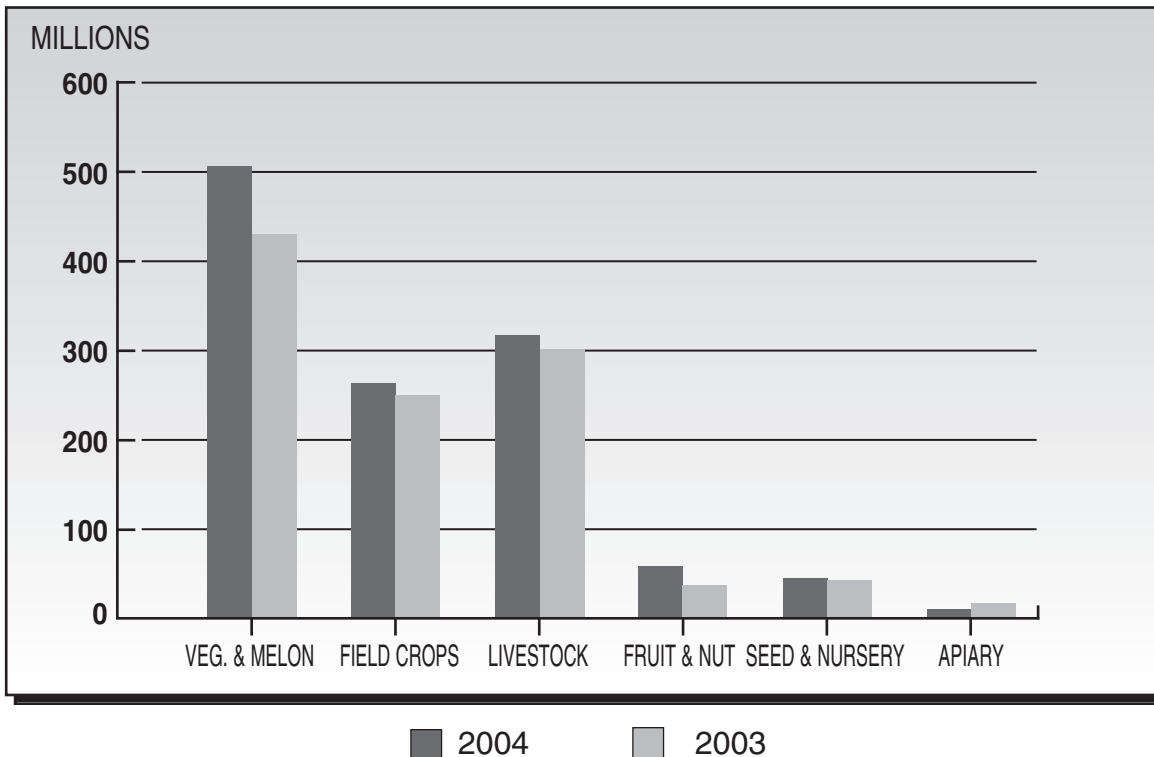
