### WHO WORKS HARDER?

A recent article by Janice Neipert Hedges (Monthly Labor Review, July 1983) on U.S. job commitment noted that women as a whole are less likely than men to work year round (57% versus 71% in 1979), but that this is not the case for single women compared with single men. The proportion of time at work actually spent working and the level of effort expended are reported to be higher for women than for men.

# MINUTES OF ANNUAL BUSINESS MEETING OF COMMITTEE ON OPPORTUNITIES FOR AND STATUS OF WOMEN IN AGRICULTURAL ECONOMICS

### Finance:

Margo Ogus reported we have \$100.83 in a Bank of America account. Ardelle Lundeen reported a balance of \$450.59 in her computer account.

### Membership:

Mary Templeton is soliciting contacts in each agricultural economics department and in industry to provide us with names of potential members.

She reported favorable results from the get acquainted session at the December meetings of the Allied Social Sciences. Plans for next December are to have a similar meeting at the Hilton Hotel, Rosewood Room, December 28, 1983, 4:30 p.m., in San Francisco, CA.

### Professional Activities:

Christina Gladwin reported on a very successful Invited Paper Session. A discussion followed regarding the fact that "women" did not appear in the session's title where it appropriately belonged and that our committee was not

identified as its sponsor. A MOTION was made, seconded, and passed to request that the board establish a policy whereby sessions that we propose and are selected, be so identified in the printed program.

### Graduate Students:

Sylvia Lane reported for Caroline Bolthouse. Caroline is surveying Davis and Berkeley graduate students to determine if there was a bias in admissions to graduate school. So far 63 out of 101 questionnaires have been returned. A study by Sam Logan indicated there is a bias towards women in acceptance to graduate school. Caroline's study will test this hypothesis for agricultural economics graduate students.

### Newsletter Editor:

Barbara Redman has done an outstanding job of providing us with a newsletter over the past two years. We are greatly indebted to her and thank her for her dedication. This is a demanding task and, we felt, should be rotated regularly.

### Employment:

Elizabeth Erickson thanked her subcommittee members and made a plea for more information about international jobs. Issues which this subcommittee should address are dual career decisions and problems and institutional biases against hiring husband/wife combinations in the same department.

It was MOVED, seconded, and passed that we establish an official subcommittee for liaison with CSWEP to establish a dialogue on common issues.

Plans for the 1984 meetings will be carried out by the new subcommittee. We want to continue with this year's format and will propose a session again.

We agreed to look for a new acronym for our committee. Time did not permit a decision. We will solicit ideas via our next newsletter.

MOTIONS were made, seconded, and passed to establish two additional sub-committees:

- Research Committee whose charge is to pull together current studies about women in agricultural economics and decide on future directions for research efforts to be encouraged by this committee.
- 2. Planning Committee to establish long-run goals for this committee and to suggest strategies for achieving those goals.

Election results are: Vice Chair, Sandra Batie; New Member of Steering Committee, Mary Ahearn.

A new roster will be published sometime this year. Our mailing list includes everyone on the roster plus others who want to or should receive our newsletter.

## FEDERAL "JOBS" PROGRAMS DOUBTFUL HELP TO WOMEN

A recent report of the Women's Research and Education Institute, a group serving as the nonpartisan research arm of the bipartisan Congressional Caucus for Women's Issues, has issued a report on how recent jobs legislation affects women. The report recommends that programs targeted toward construction and repair work alone, as many jobs programs are, benefit the mostly male construction workforce but ignore the vast majority of unemployed women.

### CAREERS IN THE ECONOMICS PROFESSION FOR WOMEN

This is an excerpt from a flier for high school students. The complete flier is available from Professor Bergmann, Department of Economics, University of Maryland, College Park, MD 20742.

There are about 40,000 women who make their living as economists, and about 27 percent of professional economists are women. The average woman

economist made about \$400 a week in 1981, or about \$21,000 a year.

Some women have achieved great prominence in the economics profession:

Dr. Alice Rivlin founded and has served as the Director of the Congressional Budget Office, an important arm of the United States Congress.

Dr. Anne Kreuger is head of research at the World Bank.

Dr. Juanita Kreps was Secretary of Commerce in the administration of President Carter.
