FOREWORD

This publication reports the major discussions of the twenty-ninth National Public Policy Education Conference, held September 17-21, 1979 at Provincetown, Massachusetts. The 120 participants represented most states, the U.S. Department of Agriculture, and other public agencies.

The Conference was planned by the National Public Policy Education Committee to stimulate and challenge extension workers responsible for public affairs programs to do a better job in policy education. This should ultimately lead to intelligent and responsible choices by citizens aimed at solving local and national public problems.

This year's conference focused on a single topic, "Controlling Inflation Without Excessive Recession." Specific objectives were: (1) to provide information on policy issues related to inflation; (2) to explore different approaches for controlling inflation; and (3) to share ideas and experiences in policy education dealing primarily with inflation and its impact upon the economy.

The Farm Foundation, following its policy of close cooperation with the State Extension Services, financed the instructional staff and the transportation of one individual from each Extension Service, as well as publication of this report. It will be made available to state and county extension personnel, to teachers and students and others interested in increasing understanding of public policy issues dealing with inflation.
