## INTRODUCTORY NOTE

The following list of publications represents the research activities of the agricultural economics group in the California Agricultural Experiment Station and the California Cooperative Extension Service. The California Agricultural Experiment Station includes the members of the Giannini Foundation of Agricultural Economics in the Department of Agricultural and Resource Economics, University of California, Berkeley, and in the Department of Agricultural Economics, University of California, Davis. The California Cooperative Extension Service includes the Extension economists who are members of the Giannini Foundation and who are located on the campuses of Berkeley, Davis, and Riverside, and the field office in Parlier. Although not every publication has been included, it is sufficiently comprehensive to represent the research work accomplished during the period covered. All titles included in this issue have been received by the Giannini Foundation Library and housed there. A few titles received after the publication of the 1979-81 list have been included here. The list serves not only as a record of published materials but also as a reference guide to source material in the area of agricultural and resource economics research.

This list is in two parts. Part I, Economic Classification, includes all of the publications classified into various economic categories. Part II, Commodity Classification, includes only those items which pertain explicitly to particular farm products, with the titles on a single group of products brought together under each sub-heading. The arrangement in each section is alphabetical by title.

Information on the availability of the listed publications is given in the following section.

Economic Research of Interest to Agriculture was first issued in May, 1951, by Orpha E. Cummings, Head Librarian of the Giannini Foundation Library from 1930-1958. Triennial supplements have been issued since 1952. Miss Cummings was the first librarian appointed to the Giannini Foundation and was instrumental in the organization and

development of this research library in the field of agricultural economics. She also organized the Agricultural Economics Library at the University of California, Davis, in 1951. At the time of her retirement in 1958, George Mehren, Director of the Giannini Foundation, wrote to her, "The fruitfulness of our research work and of our teaching as well has depended heavily on the contribution you have made to our work over almost three decades. The flavor of the Giannini Foundation shall always bear the imprint of your work" [in California Monthly, October, 1983, p. 33]. Indeed, the "imprint" of her work remains not only in the physical organization of the Library but also in the strength of its collection. Due to her efforts, to her commitment, and to her foresight, researchers from around the world can delve into a vast resource of materials in the area of agricultural economics and related fields. Miss Cummings died on June 28, 1983, in Santa Rosa, California where she lived in retirement and where she maintained through reading, a continued interest in significant world events. This supplement is dedicated to her.

Grateful acknowledgment is made to Susan Casement for sending us the Davis Giannini Foundation members' publications; to Grace Larsen for biographical information on Orpha Cummings; to Cookie Takeshita for helpful comments; and last but not least to Jeannie Imazumi-Wong for her knowledge in the application of UNIX nroff commands and for her helpful suggestions and recommendations in formatting this publication. An apology is extended to the computer users of the Department of Agricultural and Resource Economics who may have been inconvenienced on those days when we were formatting this work.
