INTRODUCTORY NOTE

The following list of publications represents the research activities of the agricultural economics group in the California Agricultural Experiment Station, California Agricultural Extension Service, Giannini Foundation of Agricultural Economics, the Department of Agricultural and Resource Economics, Berkeley, and the Department of Agricultural Economics, Davis, University of California.
